The American Rottweiler Club understands the need to provide guidelines for members when affiliate clubs call upon them to judge their sweepstakes assignments and has adopted a point system to help facilitate a candidate's qualifications.

All approved AKC Judges for other breeds must complete Section I. AKC Judges applying to be able to judge a National Sweepstakes or Futurity, must have attended a Rottweiler Judges Breed Seminar and complete Section II. E. as well.

All applicants who are not already an AKC Judge must complete all Sections.

#### **Requirements**

- Applicant must have a minimum of 10 years documented involvement with the Rottweiler.
- Applicant must have judged a minimum of 2 matches, either all-breed or Rottweiler, with at least 15 entries each to be approved to judge Regional Sweepstakes; 4 matches to be approved to judge National Sweepstakes or Futurity.
- Must have a minimum of 25 points total from A, B, C and D; and no more than 5 points from E and F.
- Must have attended a Rottweiler Judges Breed Seminar.
- Minimum of 30 total points to be approved to judge a Regional Sweepstakes.
- Minimum of 45 total points to be approved to judge a National Sweepstakes or Futurity.
- Applicants must attach documentation for all points checked.
