<u>Versatility Committee:</u> The Versatility Committee is working hard and plan to give AKC Scent work a category of its own for 2022 awards. By adding this new category, there will need to be changes to the Requirements as well. We hope to have this completed before the end of the year and to the Board for review/voting and posted shortly after for the membership to view. The Committee of four has not been in agreement on several items and for this reason we ask the Board to appoint a 5th member. One topic that has been discussed all year is if Preferred Obedience should be given equal points and recognition as Regular Obedience since the main difference is only jump height. A detailed argument for both sides were provided to the Board as well as the Preferred title stats from 11/2015- 9/2021. Stats show many of the Rottweilers who earn Preferred titles also have earned, or go on to earn, the Regular titles at that same level. There has not been a Preferred OTCH (POC) yet and only two Preferred UDX's (PUTD) who also had or earned a regular UDX. In comparison there were 4 Rottweiler OTCH titles and 16 UDX titles in the same period of time.
