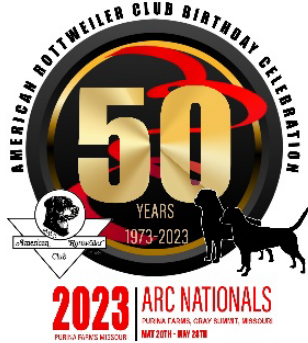

- ✓ You must waive the signature requirement for delivery services, if applicable.
- ✓ A separate entry form must be completed for each dog entered. Please use care in clearly indicating which days, classes, courses (A or B) and stock you wish to enter for each dog.
- ✓ Entries for a maximum of ten (10) dogs are allowed in each envelope, regardless of the number of classes entered. Envelopes containing entries for more than ten dogs will be treated as invalid entries and returned.
- ✓ Entries must be signed and include the full AGREEMENT. Unsigned, incomplete, or illegible entries will not be accepted.
- ✓ Entries submitted without correct entry fees will not be accepted.
- ✓ Confirmation of entry will be sent via email if an email address is included on the entry form.

Emailed entries with PAYPAL payment accepted as follows:

- ✓ Entries must be submitted on an official AKC Herding entry form.
- ✓ Entry forms must be complete, physically signed, and include the agreement.
- ✓ Entry forms **MUST be scanned as a PDF** and sent via email as an attachment to the Event Secretary at: theresa@gameonk9events.com
- ✓ Photos of the entry form **WILL NOT** be accepted.
 Submit PayPal funds to GameOnK9@gmail.com for proper credit, please reference: ARC on your payment.
- ✓ A processing fee of 6% of the total entry fee will be charged.
- ✓ The 6% processing fee **MUST** be added to the total entry fees and included in the PayPal Payment. **Entries without the 6% processing fee will not be accepted.**
- ✓ Upon receipt of both the properly completed entry form, **and** the PayPal payment confirmation with the 6% processing fee, your entry will be processed.

Rottweiler Preference Period

From trial opening on 3/6 until 8:00 am on 3/20, only Rottweiler entries will be put into the trial. Entries for all other breeds will be put on a wait list in the order in which they were received. On March 20, all other entries will be added to the trial until the trial limits are reached, and the rest will be on the alternate list. **No special consideration can be given to Rottweiler entries received after 8 am on March 20, 2023**

Trial Information

Trial site will be available from 7:00 am to one hour after the conclusion of the trial. Bring your own chairs and water for your dog. Draw will be held Tuesday, April 11, at 8:00 pm at: 13985 Le Sabre Dr. Florissant, MO

Move-ups

Dogs shall be moved up to a higher class at the request of the owner, provided that the request is made to the Event Secretary no later than one-half hour before the start of the trial and that there are open runs available in the class. Email notice is acceptable.

Notice to Exhibitors

- The safety of the dogs is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport.
- Entry fees will not be refunded in the event a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee, judge or veterinarian.
- The American Rottweiler Club may cancel this event in extreme weather conditions.
- Entry fees will not be refunded if the events cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the event site. In such case, no refund of any fees paid will be made.
- Entries must be made on Official AKC entry forms or copies and must include the signed Agreement and Rules. Include only AKC titles on entries.
- No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.
- Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries.
- Post-dated and returned checks do not constitute a valid entry fee. There is a \$25 returned check fee.
- No refunds will be issued for overpayment of less than \$10.
- Bitches in season will be permitted to run. Please notify the Event Secretary if your bitch is in season.
- Entry fees will be refunded to alternates who decline to be placed on the alternate list. Entry fees of alternates who do not participate in the test or trial will be refunded. Entry fees will not be refunded to a scheduled entrant who is absent on the day of the event unless an alternate is present and runs in the place of the absent dog.
- Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. ARC has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.
- All dogs must be on leash or crated at all times, except when in the trial area.
- Dogs must wear a simple well-fitting buckle, snap-lock or slip collar (no tags), or may work without a collar at trial levels.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites and any communicable diseases and have appropriate vaccinations.
- Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement.
- American Rottweiler Club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.
- American Rottweiler Club, their Board and Members and Purina Farms and its employees will not be liable for any loss or injury which may be sustained through disappearance, loss, theft, communicable disease, parasites, injury and/or death of dogs entered in this event.



Ribbons/Rosettes

Ribbons will be awarded to First Place through Fifth Place in each class. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs must qualify to receive ribbons.
